What is Known

- Signatures were submitted 6/28
 - SoS will decide by 8/2 if it qualifies for the general election ballot
- Constitutional Measure
- Majority Approval to Pass
- Effective January 1, 2025
- Estimated cost: \$1.329 billion per year

Measure Says...

Political Subdivisions may not raise revenue through levying any tax on assessed value of real or personal property. (Residential, Commercial, Agriculture)

The State shall provide annual property tax revenue replacement payments to political subdivisions in an amount equal to what levied in 2024.

Political Subdivisions may not longer utilize General Obligation Bonds but may continue to levy property tax if the tax was dedicated for the payment of bonded indebtedness.








PROPERTY TAXES



State Contribution Levels

The state contribution is not required to increase from **2024 levels**;

Political subdivisions additional revenues.

It is unclear what other taxes or fees would be created or raised to meet future needs and subsequent impact that would have on business.

Creates uncertainty needs

Lacks Equality & Stability

Raising revenues may be difficult for rural areas.

Industries that pay in lieu of taxes would not be included in the tax relief resulting in inequities in those industries.

This tax relief only applies to those that own property.

Schools would lose the workforce.

Does not foster long-term revenue stability.
